

## NOTICE INVITING TENDERS

### PROJECT:

Sealed tenders from interested bidders for supply, installation, commissioning and testing of a Diesel Generator 60kVA of approved make and model for its office at D-47, Block 2, Clifton, Karachi, according to the prevalent SPPRA rules.

### ELIGIBILITY:

1. Bidders shall have a Valid registration with SECP and PEC in appropriate category.
2. Bidders shall have more than 10 years' experience in relevant works.
3. Bidders shall have valid NTN and GST registration certificates.
4. Bidder shall be a direct importer or manufacturers licensed agent.
5. Bidder shall prove to have a turnover of more than PKR 150 million/ year in the business of related projects.
6. Bidders shall provide an undertaking showing that they have never been blacklisted.
7. Bidders shall provide details of facilities of after sales service and ready stocks of spare parts.
8. All works shall be completed within 30 days.
9. Bidders shall deposit a DD of 2% of the amount of the financial bid.

### BIDDING DOCUMENTS:

Tender Documents can be acquired by writing a letter on company letterhead and depositing a DD of PKR 5000 by hand. All bids shall be valid for a period of 90 days. Last date of acquiring tender Documents is 1200 hrs on 28 May 2012. The last date of submission of bids is 1200 hrs on 7 June 2012. Inquiries can be sent to the address given below before 31 May 2012, after which no inquiries shall be entertained. Technical Bids shall be opened at the SLMDCL office on 1230 hrs on 7 June 2012. Date of opening of financial bids shall be 14 June 2012.

- a. Bidders shall visit the site and submit their proposals complying with the bidding documents.
- b. A Two stage, single envelope process shall be used for selection of successful bidders.
- b. Technical Proposal shall be evaluated on the basis of criteria mentioned in the Bid Document.
- c. Financial bids shall be evaluated on the basis of lowest prices.
- c. SLMDCL reserves the right to reject all or any bids subject to the relevant provision of SPP rules.
